# NW tourism operators recognised

A KING Island accommodation business, a tour operator who provides visitor experiences across the North-West and a luxury resort overlooking Bass Strait have all been recognised in this year's Tasmanian Tourism Awards

Red Rock Hut, a tiny house nestled on the coast at Bungaree on King Island's west coast, collected the new tourism business award at the 2024 awards and has now claimed its first gold in the self-contained accommodation category.

Tour company eGuide also secured its first gold at the awards held in Hobart on Friday night, taking out the Tour and Transport Operators category in recognition of its innovative and sustainable approach to guided experiences across the North-West.

Another first-time winner, the Smithton Visitor Information Centre, was awarded gold for visitor information services, acknowledging its work to welcome and assist travellers exploring the Circular Head region.

The Cove Tasmania continued its impressive streak, taking home gold for excellence in accessible tourism for the second consecutive year.

A team of 26 independent judges decides the winners based on 7500-word written submissions, a business verification review, digital presence and consumer ratings across a 12-month period.

# 'Diplomat Dan' hits out as appeal dismissed

A SOVEREIGN citizen who refers to himself as "Diplomat Dan" has accused a Supreme Court judge of conspiring against him with his former psychologist.

The accusations came after Justice Robert Pearce dismissed an application made by Daniel Victor Gandini, or Diplomat Dan, who took his former psychologist, Michael John Marriott, to court in civil proceedings for taking out an interim restraint order against him.

During Dan's previous court appearance on October 15, he accused Mr Marriott of intentionally trying to cause mental harm and a magistrate of being biased in granting the interim restraint order against him.

Dan made his latest appearance in the Supreme Court of Launceston on Friday via video link from jail, with Mr Marriott's lawyer also appearing over the phone.

Justice Pearce handed down his decision on the matter, telling the parties that he dismissed Dan's application to review whether the restraining order should have been made.

"So, you've dismissed the restraint order?" Dan, who represents himself in court, asked Justice Pearce.

"No, I haven't. I've dismissed your appeal," the judge replied.

"So, you've conspired with Mr Marriott today," Dan said, before saying that he would have to appeal the judge's decision.

Justice Brett said Dan was entitled to appeal his decision and would receive documentation of the decision later that day.
